



NOTICE OF FINDING OF NO SIGNIFICANT IMPACT and RECORD OF DECISION

The Federal Aviation Administration (FAA) has announced that a Finding of No Significant Impact (FONSI) and Record of Decision (ROD) has been approved based upon results of a Final Environmental Assessment prepared in May 2025 for the proposed Concourse B Expansion at Sacramento International Airport (SMF), Sacramento, Sacramento County, California.

The following project is addressed by the FONSI:

- Expansion of Concourse B to accommodate six additional aircraft gates and associated holdrooms
- Construction of additional concessions facilities in Concourse B
- Two new restroom banks
- Modification of the Concourse B security checkpoint to add two lanes
- Addition of two new baggage carousels at Terminal B baggage claim
- New airfield pavement to accommodate the expansion of Concourse B
- Reconstruction of portions of Taxiways A, Y, B1, and Y4 to conform to FAA design standards
- Extension of hydrant fuel lines around the expanded concourse
- Realignment of existing fuel pits at Concourse B
- Connection of hydrant fuel line to the fuel farm

The FAA's Federal actions for this project include:

- Unconditional approval of portions of the Airport Layout Plan (ALP) that depict those components of the Proposed Project subject to FAA review and approval pursuant to 49 USC § 47107(a)(16)(B),(x);
- Determinations under 49 USC §§ 47106 and 47107 that are associated with the eligibility of the Proposed Project for federal funding under the Airport Improvement Program and under 49 USC § 40117, as implemented by 14 CFR § 158.25, to use passenger facility charges (PFCs) collected at the Airport to assist with construction of potentially eligible development items shown on the ALP.
