Race-Neutral vs. Race-Conscious Goal

The County has implemented race-neutral methodologies that will allow the County to meet the DBE goal. The County will monitor progress towards goal achievement and adjust as necessary.

The following methods will be employed to implement race-neutral goals:

- 1) Provide information on the Department of Airports functions and its full range of contractual needs.
- 2) Offer instructions and clarification on bid specifications, procurement policy, procedures, and general bidding requirements.
- 3) Maintain a file of successful bid documents from past procurement and permit potential participants to review and evaluate such documents.
- 4) Conduct debriefing sessions on each awarded contract to explain why certain bids were unsuccessful.
- 5) Routinely issue projected procurement information.
- 6) Provide instructions and clarification on job performance requirements.
- 7) Provide information and assistance on certification procedures, subcontracting practices, and bonding requirements.
- 8) Provide assistance in obtaining bonding and financing and provide technical assistance.
- 9) Arrange solicitations, time for presentation of bids, quantities, specifications and delivery schedules so as to facilitate the participation of DBEs.

Contract Goals

The County will use contract goals to meet any portion of the overall goal that does not anticipate being able to meet using Race-Neutral means. Contract goals are established so that, over the period to which the overall goal applies, they will cumulatively result in meeting any portion of the County's overall goal that is not projected to be met through the use of Race-Neutral means.

The County will establish contract goals only on those DOT-assisted contracts that have subcontracting possibilities. It need not establish a contract goal on every such contract, and the size of the contract goals will be adapted to the circumstances of each such contract (e.g., type and location of work and availability of DBE's to perform the particular type of work).

The County will express contract goals as a percentage of the total amount of a DOT-assisted contract or the federal share of a DOT-assisted contract.
